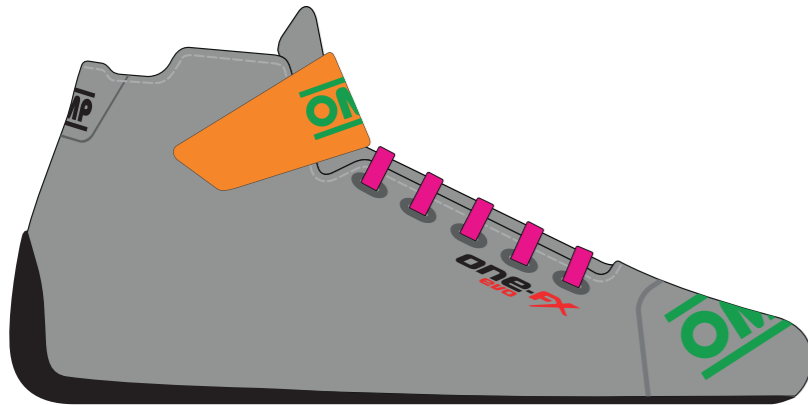

IT CANNOT BE REMOVED.

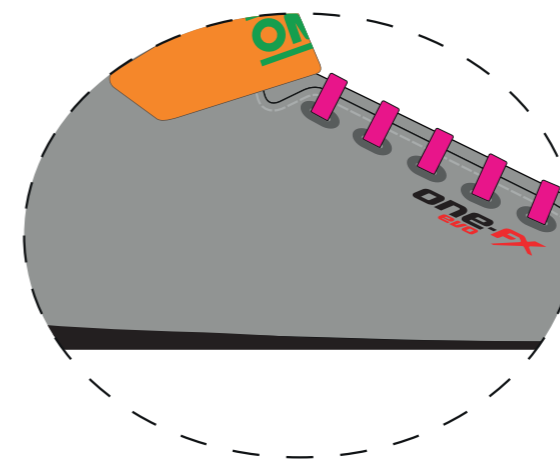
IT ALWAYS MUST BE WELL VISIBLE AND IN CONTRAST WITH THE BACKGROUND COLOR.

Customers are aware that OMP is free to change the colour of its logo in case these indications are not respected in the sketch.

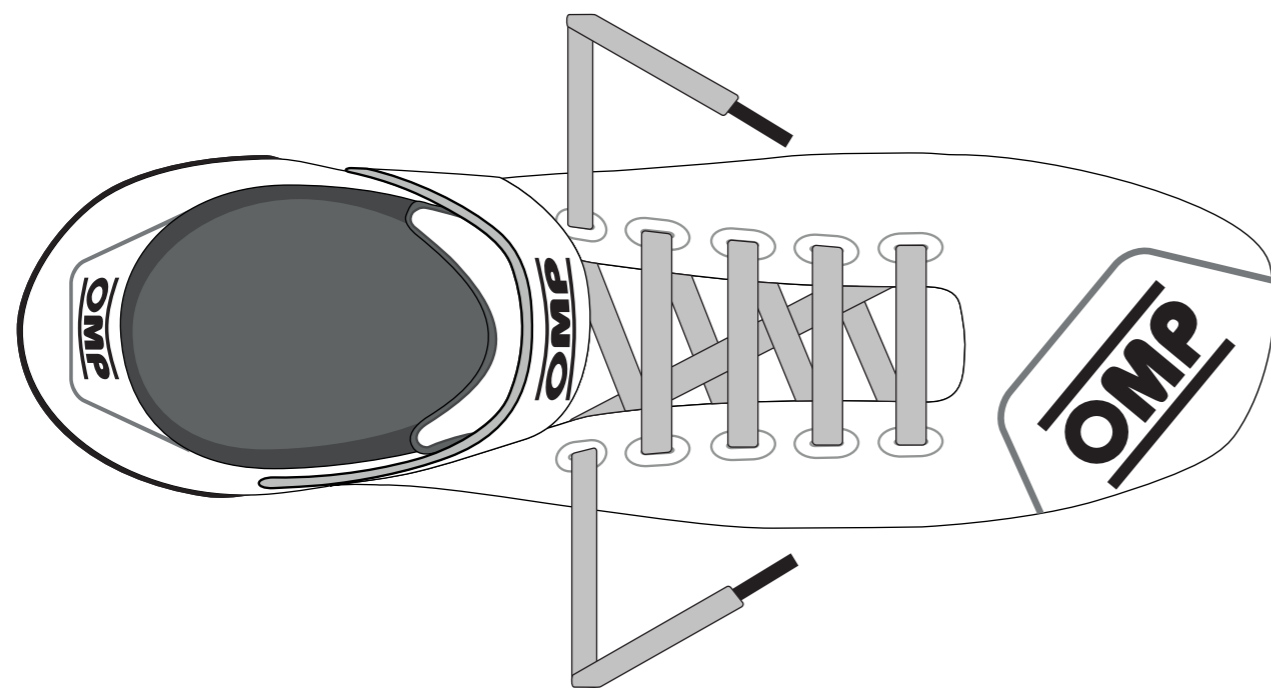
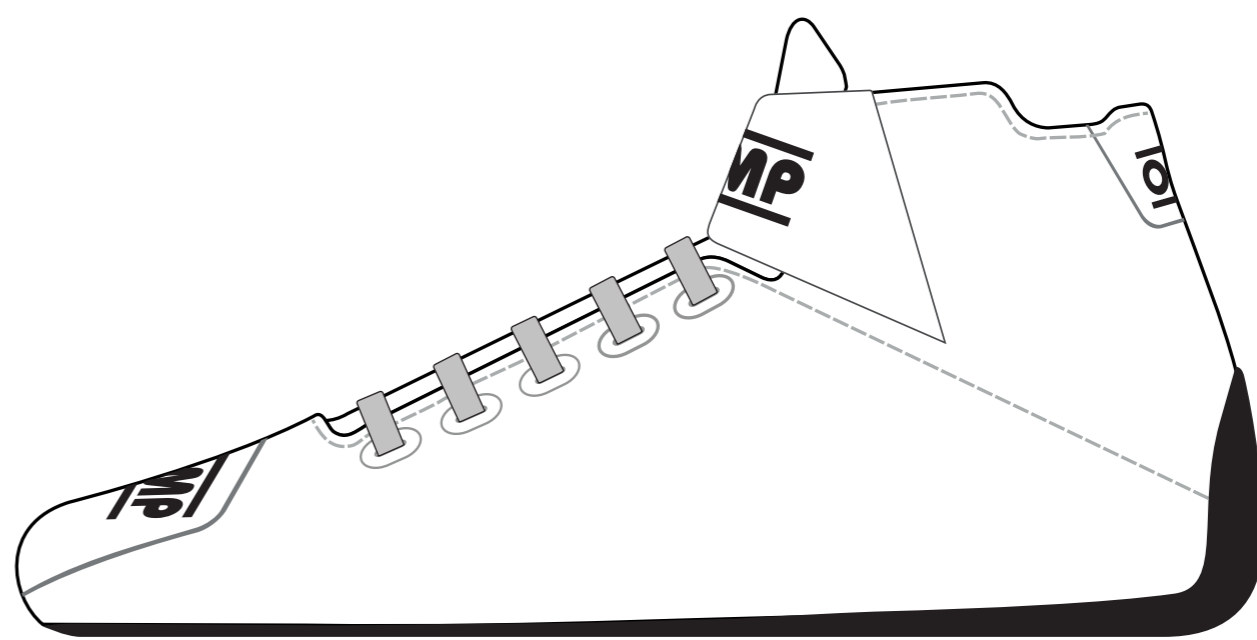
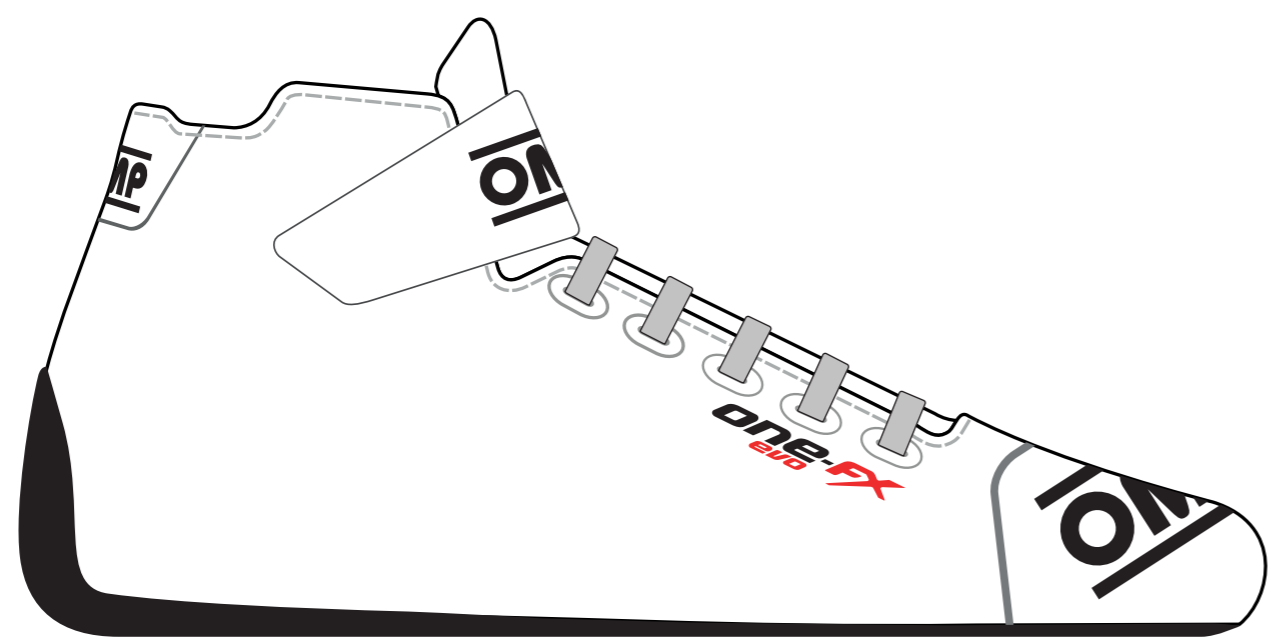
